### Conditions Of Scholarship

In the event that the scholarship is not used in a manner which complies with the conditions of this application (as determined at the sole discretion of the Awarua Trust) the scholarship shall be returned in full to the Awarua Trust upon 7 days notice. If the scholarship is not returned in full within 7 days the Applicant shall reimburse the Awarua Trust for all costs incurred (including legal costs on a solicitor / client basis) in recovering the grant.

All scholarship money must be used for the purpose applied for and approved within 6 months of the scholarship being made (or any later date agreed by the Awarua Trust in writing)

The Applicant is obliged to refund the scholarship money if they receive funding from other sources for the same purpose.

Copies of invoices, receipts and bank statements must be kept and provided to the Awarua Trust if requested to verify that the scholarship has been used in accordance with the purpose applied for and approved.

Any scholarship money which is not spent on the purpose applied for and approved must be returned to the Awarua Trust within 6 months of the grant being made.

### Consent To Audit
